Dating Violence • Domestic Violence • Sexual Assault • Stalking



TITLE IX

If you are a victim of dating violence, domestic violence, sexual assault, or stalking—whether the offense occurred on or off campus—there are multiple resources available to you. The following explains what you should do and includes a list of these resources.

REMEMBER, dating violence, domestic violence, sexual assault, and stalking are criminal acts and you are NOT responsible for another's act that violates your freedom. Dating violence, domestic violence, sexual assault, and stalking are violations of the law and BYU's Sexual Misconduct Policy.

If you are the victim of dating violence, domestic violence, sexual assault, or stalking, know that BYU is here to help and is able to take certain protective measures to ensure your safety on campus during and after a university investigation.

SEEK MEDICAL ATTENTION

IMMEDIATELY if you are a victim of sexual violence or sexual assault. You can request a sexual assault examination by contacting the police or by visiting any hospital emergency room for a referral to have a sexual assault examination completed. The examination provides care to minimize the risk of sexually transmitted diseases and preserves evidence that will be important if you decide to pursue criminal charges or wish to obtain a protective order against the person who assaulted you.

PRESERVE EVIDENCE by not bathing, showering, or using toothpaste or mouthwash after an incident of sexual assault. Do not wash clothing, bed sheets, pillows, or other potential evidence. However, if you do, you should still seek medical attention as soon as possible—even if some time has passed since the assault.

SEEK SUPPORT: Please do not feel you need to deal with this situation alone. Call a friend, family member, or someone with whom you feel you can talk. Counselors at BYU Counseling and Psychological Services are also available 24 hours a day to assist you. Contact them by calling (801) 422-3035 or (801) 422-2222 after business hours.

REPORTING THE CRIME: Deciding whether or not to report dating violence, domestic violence, sexual assault, or stalking may be difficult. Making a report to law enforcement is a decision left entirely up to you. As a victim, you may decline to notify law enforcement if you choose. If you decide to notify law enforcement, you can be assisted by campus authorities. Below is a list of contact information for local police offices:

Law enforcement can help you with orders of protection, “no-contact” orders, and restraining orders. If you are worried about retaliation against you for reporting an incident, be assured that BYU does not tolerate retaliation in any form. It is against university policy to retaliate against you, your family, friends, close associates, and anyone who provides information for an investigation. If you feel that you or a witness have been retaliated against, contact the Title IX Coordinator.

CONFIDENTIALITY: Reports of dating violence, domestic violence, sexual assault, or stalking filed with the Title IX Coordinator will be investigated as

confidentially as reasonably possible. Records kept by BYU relating to sexual misconduct allegations are not publicly available. However, if the university is required to make records publicly available, any personally-identifying information about you will be excluded to the extent that the law allows. Federal law requires the university to publicly disclose statistics about reported incidents of dating violence, domestic violence, sexual assault, and stalking; however, no personally-identifiable information is published for purposes of such reporting.

INTERIM MEASURES: Before or during the investigation, the Title IX Coordinator or Investigator may recommend that interim measures be taken to protect you or others from retaliation or further acts of sexual misconduct. Interim measures may include a change to class schedules, change in housing accommodations, counseling and medical services, academic support, a police escort to protect you, or a number of other appropriate actions. You may also request interim measures by speaking with the Investigator or the Title IX Coordinator. If requested and reasonably available, interim measures will be provided to you whether or not you choose to report the crime to law enforcement. The nature of any interim measures you receive will be kept confidential to the extent reasonably possible.

DISCIPLINARY ACTION

PROCEDURES: After you make a report to the Title IX Coordinator, BYU will initiate an investigation. This investigation is separate from any criminal investigation conducted by the police. The investigation is conducted by officials who understand BYU's Sexual Misconduct Policy and receive annual training on the issues related to dating violence, domestic violence, sexual assault, and stalking and how to conduct an investigation and hearing process that protects your safety and promotes accountability. The investigation and ultimate resolution will be conducted in a timely, fair, and impartial manner. Both you and the person who assaulted you will have the same opportunities to

present evidence and have others present during interviews or meetings. Both parties will be simultaneously informed in writing of the outcome of the disciplinary proceeding, the appeal procedures, changes to determinations, and when the determinations have become final. The investigator will use a preponderance of the evidence standard (i.e., more likely than not) in determining if dating violence, domestic violence, sexual assault, or stalking occurred. When possible, BYU seeks to conclude the investigation and resolution within sixty calendar days of receiving a report.

PROTECTIVE MEASURES AND SANCTIONS:

After a Title IX investigation is completed and a final determination is made, BYU may take steps to protect you by making interim measures permanent, offering you remedies and accommodations, implementing changes in programs or activities, or providing training for the campus community, specific groups, or individuals. The university may also impose sanctions on the person who assaulted you. Sanctions that may be imposed by the university include: Retain Record, Counsel and Education, Warning, Probation, Suspension Withheld, Short-term Suspension, Suspension, Dismissal, Part or Full-ban from campus and Reassignment to Another Position, Reduction in Pay, Demotion, or Termination of Employment. The university may use any combination of the above sanctions to discipline an individual. Discipline will depend on the circumstances and the severity of the violation.
